How your Healthcare may be Hurting You

2. General Course Information:

Purpose and Plan of this Program: This course aims to explore the history of medical error detection, correction and prevention in the US. We will start with a short executive summary of the seminal study "To Err is Human" issued by the Institute of Medicine (IOM, now called National Academy of Medicine) in 1999. This wake-up call generated actions, plans, projects, criticisms and proposed some basic solutions. We will analyze the different types of medical and healthcare system errors, like medication, diagnostic, and surgical errors and how we are currently dealing with them.

The second part of the course will discuss the US healthcare system, its flaws and negative results, and will draw a comparison with other industrialized countries. We will end with a discussion of current conditions, almost 25 years after "To Err is Human".

3. Course objectives: At the end of the sessions, participants should be able to:

- ❖ Understand the basic findings of "*To Err is Human*", its assumptions and misconceptions.
- ❖ Analyze the fallacies of the media and public perceptions of the results.

- ❖ Visualize the multiple problems of the US healthcare "system".
- * Comprehend the diagnostic process in medicine.
- Realize that doctors are not all bad or all good.
- ❖ Understand the faults of the medical education and training processes.
- ❖ Analyze the results of the Commonwealth Fund's study.
- ❖ Accept that patients have the right and responsibility to be involved in their care.
- ❖ Verbalize possible preventive and/or corrective solutions to the problem.

4. Course policies:

Registered OLLI members can participate in any or all sessions of the 8-week course. If special accommodations are required, they must be requested from and arranged through OLLI administration. Attendees may download all presentation materials which will be available at least one week before each session from the instructor-specific Box in the OLLI website. Out of respect for the time of all participants, short questions and comments during the session are permitted and encouraged. I usually have at least three question sections: at the first and second thirds during the presentation, and one at the end. Longer discussions should be done after the end of each session.

There is no required reading material. There will not be any type of testing or grading.
